

Decon Ready™ Usage Instructions



PPE Laundry Detergent

IMPORTANT: Safe for use in front loading extractors and other wash systems. Follow all machine instructions and warnings.

FIREFIGHTER AND OTHER EMERGENCY PPE: Read turnout gear and PPE manufacturer maintenance and cleaning instructions as well as NFPA 1851 Standard on Selection, Care and Maintenance of Protective Ensembles for Structural Fire Fighting and Proximity Fire Fighting. Wear protective eye wear, gloves, and for heavily contaminated equipment wear an N95 rated face mask while handling gear.

TURNOUT GEAR AND PPE DETERGENT RECOMMENDATION:

20-30 lbs: 2 oz

30-40 lbs: 3 oz

40-60 lbs: 5 oz

NOTE: Some experimentation may be required to finalize average quantities for desired cleaning. Add additional 2 ounces to each load recommendation for moderately contaminated gear.

TURNOUT GEAR AND PPE WASHING INSTRUCTIONS:

Separate liners from outer shell and wash separately. Load gear into washer observing manufacturer limitations on weight. Set water temperature to 95°F (do not exceed garment manufacturer recommended washing temperature). Follow the above detergent recommendations and pre-soak if necessary. Fill machine to full capacity with water. Wash for ten to fifteen minutes, followed by three rinse cycles. If rinse cycles are not programmable, run the wash again three times without detergent. Rinsing is very important to remove contaminants.

Following proper turnout gear and PPE maintenance, Decon Ready PPE Laundry Detergent helps prolong equipment life and will substantially reduce exposure to dangerous cancer causing carcinogens.

Decon Ready does not contain citric based cleaners such as D-limonene and will not harm uniforms or PPE hardware or damage plastic components after long-term continuous usage.

Adjustage pH prolongs the life of expensive specialized coatings.

Does not contain fragrance, optical brighteners, whiteners or bleach.

PPE & Multi-Surface Cleaner

DIRECTIONS: Mix or shake well before use ▪ Remove excess dirt, mud and visible debris ▪ Test on inconspicuous area to ensure compatibility by applying either directly or with damp cloth ▪ Upon successful compatibility testing, continue decontaminating surfaces ▪ Thoroughly rinse surfaces with water then air dry ▪ Wash hands, face, neck and other exposed skin with Decon Ready Skin Cleanser ▪ Avoid contact with eyes, flush with water
